Dick Bidwell graduated from Virginia Polytechnic Institute & State University in 1950 with a BS degree in Mechanical Engineering. He was elected a Fellow of NSPE in 2001. Dick remained active in the Air Force Reserves after serving on active duty, and retired as Lieutenant Colonel in 1988.

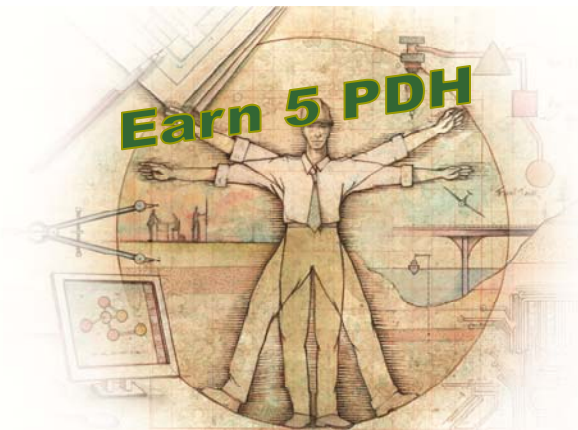
